1 - Advertising for motor vehicles is prohibited:
a) contains situations or suggestions for the use of the vehicle which could endanger the personal safety of the user or of third parties;
b) contains situations or suggestions for the use of the vehicle which disturb the environment;
(c) presents situations of infringement of the rules of the Highway Code, in particular speeding, dangerous manoeuvres, non-use of safety accessories and disregard for signs or pedestrians.
2 - For the purposes of this Code, motor vehicles are all mechanically driven vehicles intended to travel by their own means on public roads.
